1. This tournament is for sanctioned bowlers in Ontario. All CTF tournament rules and regulations shall govern this CTF sanctioned tournament. Youth bowlers above the age of 18 at the date of the tournament are eligible to enter the tournament.
2. Entries should be in by January 26, 2026, to ensure lanes are available for the shift requested.
3. Handicap will be 90% of the difference between the bowler's **Highest** average and 220. **The sanctioned average will be based on last year's (2024/25) HIGHEST Yearbook average in any association or sanctioned league. If there is no previous year average, the bowlers must use a current average based on a minimum of 21 games as of January 25, 2026.** If the bowler does not have an eligible previous or eligible current year average, the bowler will be given a 220-scratch average. Please note that CTF Rule 319(a)-2 (10-pin rule) will NOT apply.
4. **If you are using your current year average, the sanctioned league average sheet as of January 26/26 must accompany the entry forms or be presented at the event to confirm your average at the tournament.**
5. **You may enter the tournament multiple times but only cash once with the same partner.** Both bowlers will bowl three games on one pair of lanes per entry.
6. The tournament does have an option to bowl in a scratch event in both divisions of singles (men and women) each shift for an addition fee of \$10 per shift.
7. Any player arriving after the game has started will be allowed to bowl and the score(s) will count beginning in the frame being bowled. NO SCORE WILL BE GIVEN FOR FRAMES MISSED.
8. When ties occur the prize money will be combined and equally divided among tied positions.
9. Award fees will be returned to the participants on a 1 in 4 basis.
10. Protests MUST be submitted in writing to the Tournament Director within 48 hours of the completion of the tournament to Ryan Crossett at ldtenba@gmail.com.
11. Failure to comply with any of these rules will result in disqualification.
12. This tournament is first of three legs in the All Events tournament (Doubles, Singles, Team) being managed by the Lambton County District Tenpin Bowling Association. The fee for this event is paid to Lambton County at this tournament using their form.
